Footnotes

- *Figures reflect calendar year 2020 deliveries to RIRRC under each municipality's waste, recycling and school accounts, as well as figures for material delivered to other facilities as reported by municipalities to RIRRC in its annual data survey. Figures do NOT include materials classified as litter cleanup, seaweed, street sweepings, unrecoverable mattresses, disaster debris or designated as commercial waste.
- 1-Composted Material includes leaf and yard waste, Christmas trees, brush, stumps and a 500 lb. credit for each compost bin sold to the municipality's residents.
- 2-Scrap Metal includes appliances with and without Freon, auto batteries, propane tanks and other tons reported as scrap metal.
- 3-Other Recycling includes all other diverted materials: antifreeze, bicycles, books, bulky rigid plastics, clean wood, concrete, cooking oil, electronic waste, fluorescent bulbs, food scraps, household batteries, reused household items, mattresses, motor oil & filters, paint, plastic bags & film, paper shredded at special events and tires.
- 4-Materials Recycling Facility (MRF) Recycling Rate is the total tons of MRF mixed recyclables divided by those tons plus the trash tons.
- 5-Mandatory Recycling Rate includes all remaining materials on RIDEM's Mandatory Recyclables list: composted materials, scrap metal and clothing.
- 6-Overall Diversion Rate includes MRF mixed recyclables, RIDEM Mandatory materials (5) and materials listed as Other Recycling (3).
- 7-Rejected Recycling tons include contaminated mixed recycling loads that do not meet minimum quality standards, are not processed in the MRF and are subsequently landfilled. These tons are included in the second column, Solid Waste (Tons).
- 8-Hopkinton residents utilize Westerly's facilities. Narragansett residents utilize South Kingstown's, and percentage allocations of materials are based on estimates provided by the towns.
- 9-Tiverton's solid waste tons include actual tons disposed of at RIRRC and estimated solid waste tons disposed at the town's landfill, calculated by RIRRC, as the town was not able to provide the 2020 figure.
- 10-MRF Residue accounts for the non-recyclable components of the inbound MRF materials that get sorted out and disposed of as solid waste. For illustration purposes only, the italicized line applies the 24,296 tons of MRF Residue: adding them to Solid Waste tons, subtracting them from MRF Recycling tons and calculates statewide recycling rates accordingly.
